



### **Qualified Entrant and Entry**

- 1.) A **“Qualified Entrant”** is a British Columbia resident 19 years of age or older. A Qualified Entrant does not include:
  - a. BCLC employees,
  - b. BCLC Lottery Retailers and their respective employees,
  - c. As well as family and household members of same residing at the same address.
- 2.) To obtain a **“Qualified Entry”**, a Qualified Entrant must:
  - a. Purchase a 10 draw advance play Keno ticket from a participating Lotto RSG Retailer (a **“Participating Retailer”**) during the Entry Period (defined below) and receive a contest entry ballot from the Participating Retailer.
  - b. Complete and submit the ballot at that Participating Retailer location during the Entry Period. The ballot must be completed fully (e.g. full name and phone number), correctly and must be legible. The ballot must be deposited in the draw box at the Participating Retailer during the Entry Period.
- 3.) A Qualified Entrant may enter this contest more than once, however, only one (1) entry is allowed for each multiple of 10 draw advanced play Keno tickets purchased. Qualified Entrants may enter this contest at more than one Participating Retailer.

### **Entry Period and Deadline**

- 4.) The **“Entry Period”** is from the time the Participating Retailer(s) opens on Monday, March 5, 2018 to the time the Participating Retailer(s) closes on Sunday, April 2, 2018.

### **Keno Doubler RSG Second Chance Draw**

- 5.) A draw to select one (1) winner (a **“Drawn Entrant”**) at each Participating Retailer location will be made in public by two (2) Participating Retailer employees after the Entry Period ends or as soon as practical thereafter from all Qualified Entries received at each Participating Retailer location.
- 6.) The Participating Retailer shall make reasonable attempts to contact the Drawn Entrant using the contact information provided on the entry ballot. If the Participating Retailer is unable to contact the Drawn Entrant within seven (7) days of the draw, that Drawn Entrant will be disqualified and another Qualified Entrant will be drawn. This process will continue until a Winner (defined below) is selected.
- 7.) In order to be qualified to receive a prize (a **“Winner”**), the Drawn Entrant must be verified to be qualified to participate in this contest by the Participating Retailer and complete such releases, waivers or indemnities as required by BCLC or the Participating Retailer.

### **Prize**

- 8.) There will be one (1) prize awarded at each Participating Retailer in B.C. for a total of 203 prizes. Each prize is a VISA pre-paid gift card valued at \$100 CAD (the **“Gift Card”**). BCLC



or the Participating Retailer may, at their sole discretion, substitute the Gift Card with an equivalent cash prize.

- 9.) The Winner must claim the prize in person at the Participating Retailer on a date specified by the Participating Retailer. The Winner must claim their prize within 30 days of the date the draw is made.
- 10.) The Winner is responsible for all costs associated with claiming his or her prize, including transportation to and from the Participating Retailer.
- 11.) In order to claim his or her prize, the Winner must provide government-issued photo identification to the Participating Retailer.

#### **Other Conditions**

- 12.) It is the responsibility of each Qualified Entrant to ensure that his or her contact information is current, correct and legible.
- 13.) In no event shall BCLC or a Participating Retailer be liable for a Qualified Entrant not receiving notification of the fact that his or her name has been drawn.
- 14.) By entering this contest, each person consents to the collection, use, access, disclosure and storage of his or her personal information inside and outside of Canada.
- 15.) BCLC and Participating Retailers reserve the right to disqualify entrants and/or entries that do not comply with these conditions.
- 16.) Neither BCLC nor a Participating Retailer is responsible for incomplete, lost, misdirected, misplaced, illegible or damaged ballots or entries or ballots or entries submitted after the end of the Entry Period.
- 17.) BCLC may at its sole discretion and without liability to anyone, alter, amend, suspend, or cancel this contest, the selection procedures or these contest conditions at any time.
- 18.) Decisions of BCLC are final and binding.
- 19.)
